

MODERN AND EFFICIENT INFRASTRUCTURE

- AN AUTONOMOUS PORT with computerized procedures, working non-stop and equipped with a container terminal.
- AN INTEGRATED SPECIAL ECONOMIC ZONE (ZESI) under construction and intended to provide a range of infrastructure and services to businesses.
- A NEW INTERNATIONAL AIRPORT (AIBD) with an annual capacity of 3 million passengers, in its final phase of construction. Daily air connections linking Dakar to the major capitals.
- A MODERN MOTORWAY built through public-private partnership to improve urban mobility and linking Dakar to the ZESI, AIBD and regional competitiveness centres.
- TRAFFIC ROUTES LINKING DAKAR TO 5 BORDERING COUNTRIES (Guinea Bissau, Mali, Mauritania, Guinea Conakry, Gambia).

Senegal is positioned as a regional hub. Multimodal transport with a perfect integration of the road, rail and maritime routes to promote the competitiveness of businesses, by reducing the time spent in the handling and storage of imported or exported goods.

• A FULLY DIGITALIZED TELECOMMUNICATIONS NETWORK with a 3000 km optic fibre loop and the presence of the 3G throughout the country.
