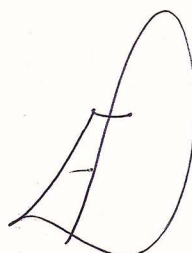


The overall objective is to contribute to the development of competitive industry and business sector mainly through the promotion of products and services.

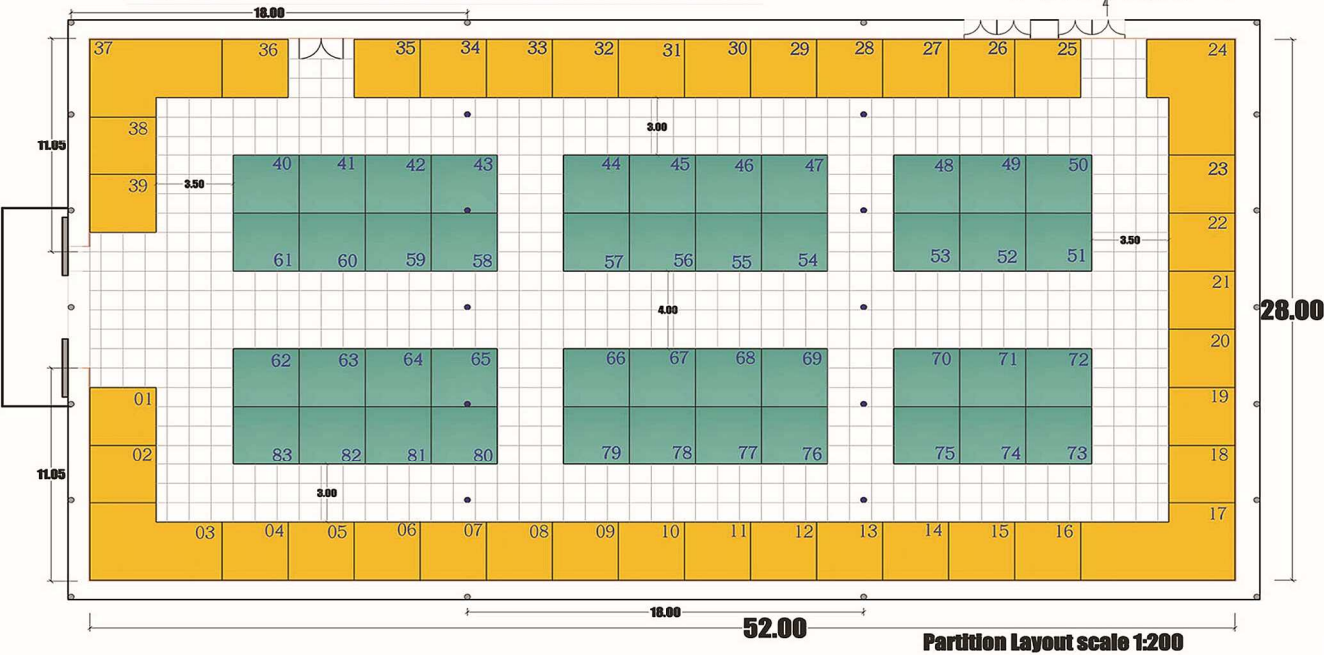

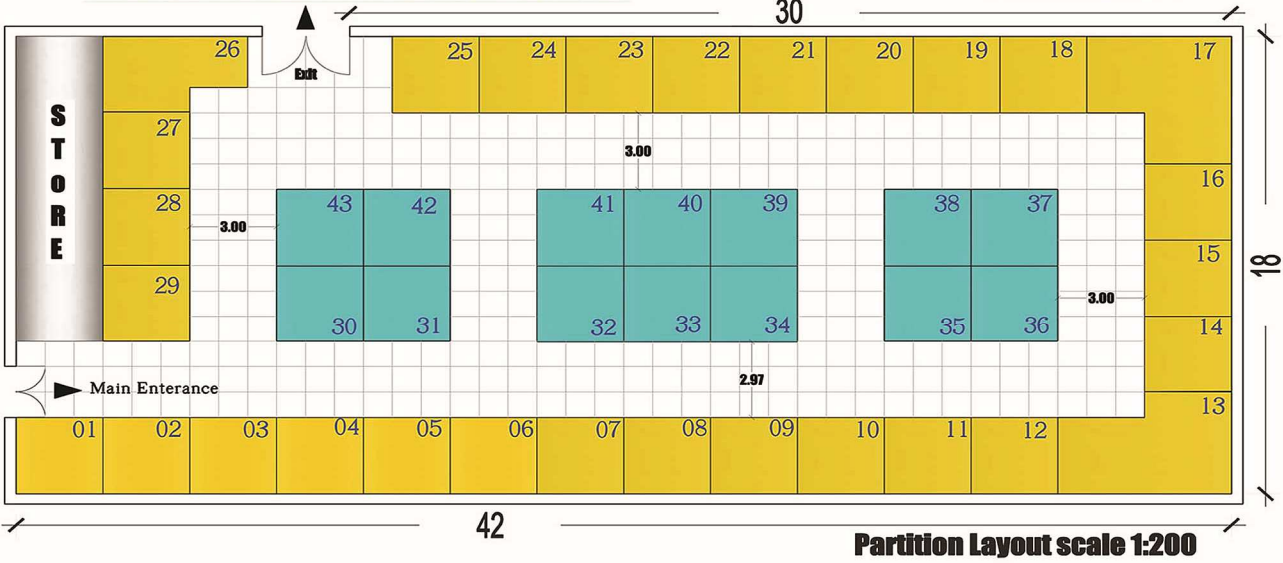

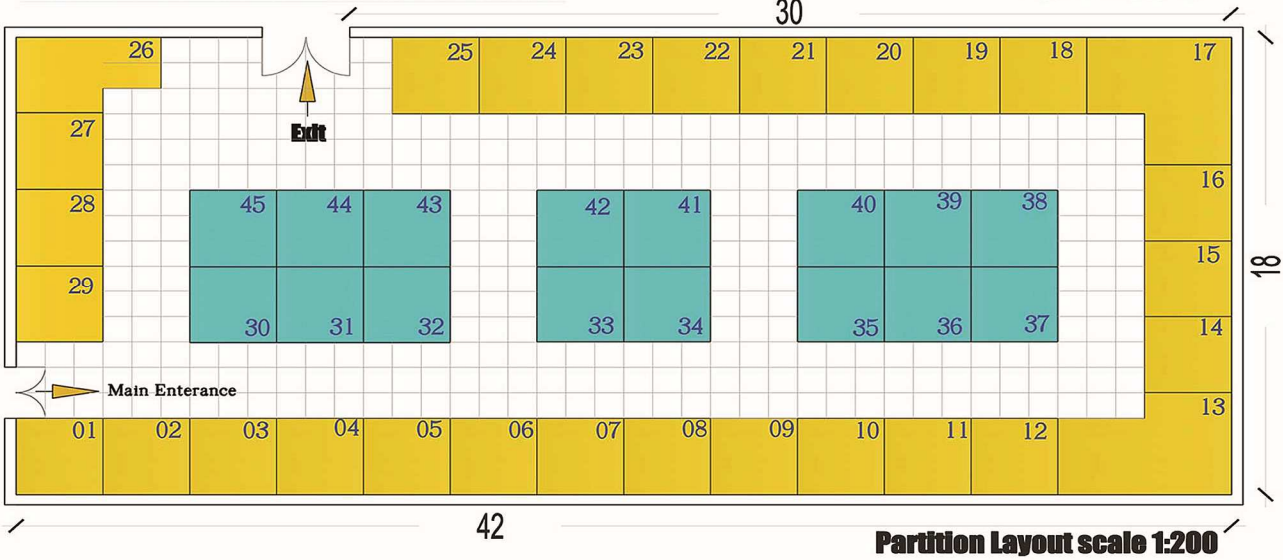
